Sea level rise causing coastal inundation has forced the relocation of seven households in Narikoso Village, Ono, Kadavu and Waciwaci District School on Lakeba, Lau

SUGGESTED WAY FORWARD

EIA report for both relocation sites currently in progress <u>Narikoso</u>

- Site layout approval (Min. Health)
- Phase 2 of livelihoods training
- Procurement of construction materials
- Construct 7 households before Christmas 2018



<u>Waciwaci</u>

- Complete all required ground and hydrology (borehole) assessments
- Site plan approval (Min. Health)
- The project aims to have relocation site prepared before end of 2018









CONCLUSION

Relocation is the last resort albeit a reality

- Lessons learnt from Narikoso and Waciwaci will stream line processes for future relocation initiatives
- Communication among all stakeholders is vital in this process for sustainability of the project.
