

# Talanoa Dialogue (01 January - COP24 Dec 2018)

- 26 January: Online platform launched
- May TD: prov. set for Sunday 06 May ——> summary report posted on the TD platform
- May October: series of talanoa sessions to contribute to the TD (including CAPP Conference, Global Climate Action Summit, Technical Expert Meetings)
- 29 October: final deadline for submissions ——— synthesis report
- October IPCC report on 1.5degCelsius
- COP24 Political phase high-level representative of Parties; Ministerial level



# Regional NDC Hub (July – December)

- July 26 27: CAPP Conference —— Talanoa session (likely by thematics)
- July before 29 October ——— submissions by organisations, coalitions, initiatives and/or sectors
- Organising a talanoa Sector specific ? Mitigation/adaptation/resilience? Means of implementation (financing, technology, capacity building)? Organisation/initiative? Etc?
- Will the Hub be well established during this period?

## Another approach

- Organisations of the hub draft submissions promoting the role and functions of the hub
- Parties and non-Party stakeholders preparing submissions highlight the role of the hub





# Preparing submissions... some guidance

### Where are we?

- The commitment (planned and/or announced) as well as the actions taken so far that are in line with aims of Paris Agreement, the 1.5/2 degrees' goal and the transition towards a net-zero emission society by this mid-century
- Progress made so far against the above commitments, including success stories, case studies and gaps
- Quantitative impact so far with respect to mitigation, adaptation, resilience and/or finance

#### **REGIONAL HUB**

- 1. Provide advisory and technical support to Pacific Island Countries...
- 2. Support PICs with the required systematic review of the implementation of their NDCs and the acceleration of climate actions...
- 3. Strengthen the monitoring and reporting of NDCs in the region and align this to [...] other national and regional reporting mechanisms.

# Where do we want to go?

- Vision of the future for your organisation and/or sector in terms of its possible role in achieving the 1.5/2 degrees' goal and a net-zero emission world by this mid-century
- Possible and potential new commitments and pledges of to achieve the 1.5/2 degrees' goal and a net-zero emission world by this mid-century
- Foreseen positive impact of these commitments once they are realized, including contributions to the sustainable development agenda

#### **REGIONAL HUB**

- 1. Provide advisory and technical support to Pacific Island Countries...
- 2. Support PICs with the required systematic review of the implementation of their NDCs and the acceleration of climate actions...
- 3. Strengthen the monitoring and reporting of NDCs in the region and align this to [...] other national and regional reporting mechanisms.



# How do we get there?

- Ways in which the UN Climate Change process can help you achieve your vision and goals, and how your actions can help in expediting sustainable transitions to climate neutral societies
- Concrete solutions that have been realised while implementing your commitments, including lessons learnt
  from success stories and challenges, and case studies that are in line with the 1.5/2 degrees' goal that can
  support the Parties in achieving their NDC goals, enable higher ambition and inspire engagement of other nonstate actors
- Collaboration models with other stakeholders and, in particular, between non-Party stakeholders, national
  governments and the UN Climate Change process that have been successful in helping you, or can help you,
  achieve your commitments.
- Opportunities to further scale up action and means to address barriers that can enable even further action
   ("We've made progress and have made new commitments as described above. This is what I need from
   national governments, other non-Party stakeholders and the UN Climate Change process to take even further
   action...")
  - Policy levers
  - Collaboration/cooperation opportunities
  - Lessons learned based on the experience and progress so far
  - Public and private financing models
  - Impact on non-Party stakeholders if these actions by national level governments and the UN Climate Change process and other opportunities are implemented and how much further they could go
